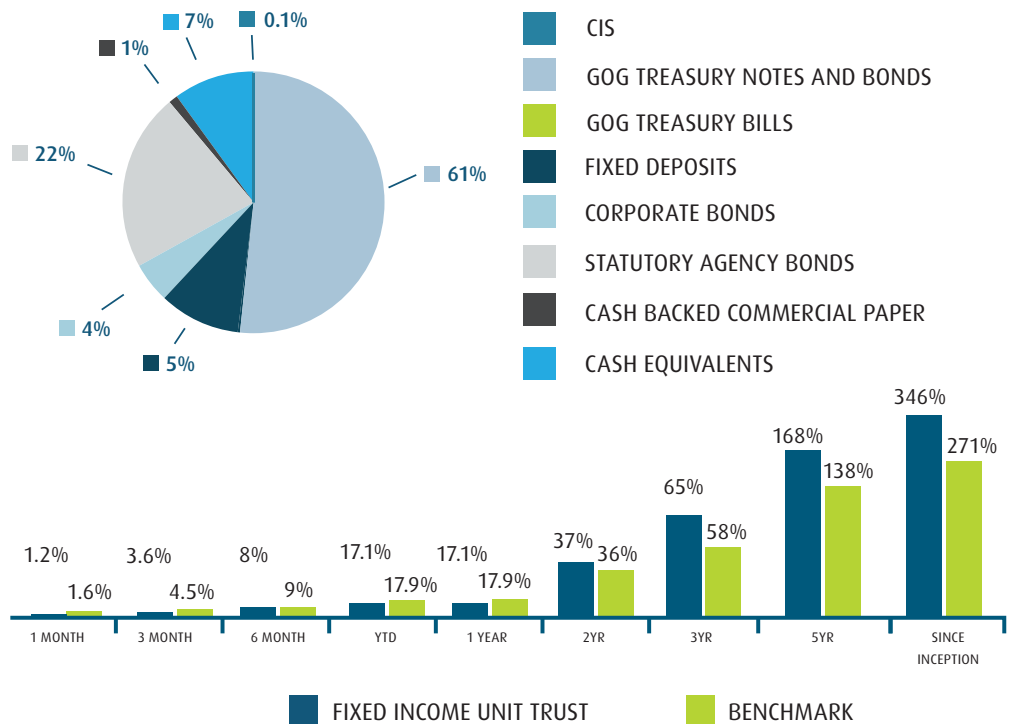
Investment Objective

The EDC Ghana Fixed Income Unit Trust posted a return of 1.17% in December to close the year at 17.1%, an improved performance against 2018 return of 16.9%.

Since inception, the fund has recorded a Compounded Annual Growth Rate (CAGR) of 22.28%.
