## RESULTS OF THE RIGHTS ISSUE

African Alliance is pleased to announce the results following a successful Rights Issue of Societe General Ghana Limited (SOGEGH) which run from 9 - 23 September 2016.

During the period, we received 1,022 applications from qualifying shareholders subscribing for a total of 61,778,911 shares compared with 65,880,695 shares on Offer. The Offer therefore raised GHS 38.30million compared with GHS 40.85million the Bank sought to raise representing a subscription rate of 93.77%.

After fully allotting a total of 44,208,250 entitlements and 17,570,661 extra shares to qualifying shareholders, a total of 4,101,784 shares valued at GHS 2.54million were unsubscribed for. The table below provides a summarised breakdown of the Offer results:
