Pursuant to Rule 40 (i) of the GSE listing Rules, Scancom PLC (MTN Ghana) wishes to announce the following changes in Auditors and Directors Pursuant to Shareholders ordinary resolutions at the 3rd Annual General Meeting (AGM) of Scancom PLC held via live video stream, from the head office of Scancom PLC, MTN House, Independence Avenue, Accra on 25th May, 2021.

1. CHANGE IN DIRECTORS - MR. RALPH MUPITA AND MS. TSHOLOFELO MOLEFE

Mr. Ralph Mupita stepped down from the Board of Scancom PLC effective May 25, 2021. He was replaced by Ms. Tsholofelo Molefe, who was appointed as a director of Scancom PLC effective May 25, 2021 pursuant to an ordinary resolution of the Shareholders of Scancom PLC.

Ms. Tsholofelo Molefe is the current Chief Financial Officer (CFO) of MTN Group. Ms. Molefe is a qualified Chartered Accountant, and prior to joining MTN, had direct exposure to the telecommunications industry, having been the Group Chief Financial Officer at Telkom SA SOC Ltd, since 2018, as well as its Chief Risk Officer and Deputy CFO prior to that. She brings with her extensive financial and accounting experience, with a strong background in enterprise risk management and internal audit. Ms. Molefe's track record of financial leadership will be of great value to Scancom PLC.

Messrs. Ernst & Young (EY) were appointed Auditor in place of PwC (who have been the Auditors of Scancom PLC for over 6 years) effective the end of the May 25, 2021 AGM, by ordinary resolution of the Shareholders of Scancom PLC.
